WE PRODUCED AND RELEASED RESEARCH REPORTS DOCUMENTING THE COMMUNITY BENEFITS OF THIS WORK IN LOS ANGELES COUNTY, CALIFORNIA, AND IN A MULTI-STATE REGION IN THE NORTHWEST, INCLUDING OREGON, WASHINGTON, IDAHO AND MONTANA.

WE KNOW FROM SURVEYS THAT THIS WORK IS MAKING AN IMPACT. FOUNDATION LEADERS REPORT THAT NCRP IS HELPING RAISE THE DISCOURSE ABOUT EXEMPLARY PHILANTHROPY, AND NONPROFIT LEADERS REPORT THAT OUR PROJECT IS HELPING THEM RAISE MORE MONEY FOR THEIR ADVOCACY EFFORTS.

4b (Code: ) (Expenses \$ 335,125. including grants of \$ ) (Revenue \$ ) MEMBERSHIP, ALLIANCES AND COMMUNICATIONS: IN ORDER TO STIMULATE DISCUSSION ABOUT THE IMPORTANT ISSUES IN PHILANTHROPY, NCRP PUBLISHES A QUARTERLY JOURNAL (RESPONSIVE PHILANTHROPY), A BLOG (KEEPING A CLOSE EYE), AND AN ELECTRONIC NEWSLETTER (ROUNDUP). ALL WERE WIDELY READ OVER THE PAST YEAR, ESPECIALLY BY CEOS AND SENIOR STAFF OF FOUNDATIONS AND BY EXECUTIVE DIRECTORS OF OTHER NONPROFITS. MORE THAN 80 PERCENT OF USERS OF THESE RESOURCES REPORT THEM AS VALUABLE. MEMBERSHIP IN NCRP GREW SIGNIFICANTLY IN THE PAST YEAR, AND WE NOW HAVE MORE THAN 500 MEMBERS. GROWTH WAS HEAVIEST AMONG NON GRANTMAKING NONPROFITS, INDICATING THAT NCRP TRULY IS BRINGING THE VOICES OF NONPROFITS INTO DISCUSSIONS ABOUT PHILANTHROPY.

THROUGH PRESENTATIONS AT CONFERENCES AND THROUGH OUR PUBLICATIONS, WE ARE CHALLENGING GRANTMAKERS TO STRENGTHEN COMMUNITIES. A RECENT SURVEY SHOWED US THIS WORK IS HAVING IMPACT. FULLY 23 PERCENT OF FUNDERS REPORTED THEY HAVE CHANGED THEIR PRACTICES AT LEAST PARTIALLY DUE TO NCRP'S CRITERIA. THE CRITERIA SUGGEST ASPIRATIONAL GOALS FOR EXEMPLARY GRANTMAKING. FOR EXAMPLE, WE ENCOURAGE FUNDERS TO DEVOTE AT LEAST 50 PERCENT OF THEIR GRANT DOLLARS FOR THE BENEFIT OF UNDERSERVED COMMUNITIES, TO PROVIDE UNRESTRICTED GENERAL OPERATING SUPPORT AND MULTI-YEAR GRANTS, AND TO ADOPT LESS ONEROUS APPLICATION AND REPORTING REQUIREMENTS.
